IBD Certifications' mission is to apply these guidelines to inspection and certification in accordance with ISO 17065 requirements.

2. JUSTIFICATIONS

The demand for guarantees for cosmetic products as well as food, free of substances derived from animals, is constantly increasing.

To this end, IBD created the seal that will guarantee not only through a documentary conference, but also through face-to-face audits the optional, non-inclusion of substances, raw materials of origin or derived from animals.

In certified products VEGAN NATURAL INGREDIENTS, in addition to the guarantee that they are all natural raw materials, these, also with an audit guarantee, will not be made of animal ingredients or even derived from animals.

3. WHAT ARE VEGAN PRODUCTS?

They are raw materials or final products generated or manufactured without substances from vertebrate or invertebrate animals including adjuvants, additives, coloring catalysts, sweeteners, stabilizers, emulsifiers, and that the latter have also not been generated with animal products.



- They are raw materials or final products that were generated or manufactured without testing on animals of any kind.
- Vegan certification does not exempt the company from complying with other pertinent laws, technical regulations and technical standards and making statements regarding the allergenic issue of products and the possible existence of allergenic substances.

4. LIST OF PERMITTED AND PROHIBITED PRODUCTS

LIST OF ALLOWED PRODUCTS

You must ensure that all raw materials used

- does not contain any ingredients of animal origin, such as meats and substances from parts of animals or their secretions;
- ii) does not contain additives, supplements or enzymes of animal origin;
- iii) has not been processed with technology assistants that are of animal origin

When necessary, submit a declaration in accordance with Attachment I

LIST OF PROHIBITED PRODUCTS

THEREFORE EXCLUDING, FOR EXAMPLE, SUBSTANCES AND:

Milk products:	lactic acid; casein; caseinates; milk cream; yogurts; powdered milk; lactalbumin; lactitol; lactoglobulin; lactose; lactosorro; butter; cheeses; whey proteins.
Derivatives of eggs:	albumin; powdered egg white; powdered egg yolk; globulin; lysozyme; ovalbumin; egg lecithin.
Honey Derivatives:	Apitoxin; Wax; Royal jelly; Propolis; Pollen.
Derivatives of animal origin: marine animals, cattle, insects, sheep, fish, pigs, birds or any animal species.	Silk Amino Acid; Collagen and elastin, leather, gelatin, bones, cartilage; Carmine, Cochineal, Carminic Acid; Shellac; Fats;

5. LABELING

According to the National Health Surveillance Agency (ANVISA), the packaging label is any inscription, caption and image or any descriptive or graphic material that is written, printed, printed, recorded or pasted on the packaging of a product and all elements must follow the regulations in force.

Therefore, all arts must follow the regulations in force and that each standard has specific requirements.
